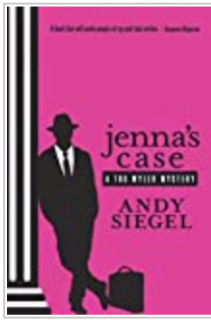




## Jenna's Case Reviewed By Michelle Kaye Malsbury of Bookpleasures.com
